No alteration in the terms and conditions of the Contract are allowed without prior the Bank's written consent to such alterations*. This quarantee is valid until and if that day falls on a day where the Bank is closed for business,

the next/first following business day (hereinafter called the 'expiry date').

Any demand for payment should be presented to the Bank at office in Warsaw, address: PKO BP S.A., Biuro Finansowania Handlu, 02-515 Warszawa, ul. Puławska 15, Poland, not later than on the expiry date.

This guarantee expires in full and automatically, should the Beneficiary's written demand for payment, not be in the Bank's possession by that date, irrespective of whether this guarantee is returned to the Bank or not.

This quarantee also expires in full and automatically, if original of this quarantee is returned to the Bank ¹.

The amount of this guarantee shall be reduced automatically by the amount of each payment made by the Bank according to the terms of this guarantee.

This guarantee should be returned to the Bank after 1:

- + its expiry date or
- + utilization or
- + in the case where either the Supplier or the Bank are released by the Beneficiary from the obligations arising hereunder.

This guarantee can not be transferred to another entity without the express written consent of the Bank.

This guarantee shall be governed by Polish law 2 .

This guarantee is subject to the Uniform Rules for Demand Guarantees, ICC Publication No. 758³.
