General Information

This document describes the structure of the file with the list of domestic or foreign counterparties as required for its correct import into the iPKO Biznes electronic banking system.

The files that comply with the below specifications can be imported into the iPKO Biznes from the menu: "Transakcje" -> "Kontrahenci" -> "Import pliku" ["Transactions -> "Counterparties" -> "File import"].

Besides standard formats, you can define your own formats using the data import creator functionality. For more information about definition of own formats, see the iPKO biznes administrator manual (login page).

Domestic Counterparties

File Description

File name and structure should meet the following requirements:

- Files can have any name possible with TXT or CSV extension;
- One file cannot contain more than 5,000 records;
- Files have neither a header nor a footer;
- Each file line describes one beneficiary;
- Each record contains a set of fields separated with semicolons (;).

Since the iPKO Biznes system has its own database of Tax Offices' accounts, such beneficiaries cannot be imported thereto. We recommend deleting all defined Tax Offices counterparties before importing beneficiaries to the internet application. This action is however not necessary, as during import Tax Offices beneficiaries will be rejected, the situation which will not interrupt import of other counterparties.

Data Structure

Content of columns in format description:

M / F = field type

M = mandatory

O = optional – can be empty

Format = field length and type

n = numerical field

a = alphanumerical field (with characters)

F = fixed-length field

V = variable-length field
