## NOTIFICATION ABOUT INTRODUCTION OF MAXIMUM LIMIT FOR ON-LINE TRANSACTIONS



As of 1 June 2023, a maximum limit per transaction commissioned on-line is introduced:

- The maximum limit is **PLN 300,000** per transaction.
- If the maximum limit is exceeded, we will inform you about it via an on-line notification, while the commissioned transaction will be confirmed and processed via telephone banking services by a telephone consultant of PKO Bank Polski
- The maximum limit does not apply to:
  - Internal transfer instruction;
  - o Early termination, additional payment or withdrawal of funds from a term deposit
  - Transactions processed with the use of payment card and mobile app to which separate daily limits are applicable.

## NOTIFICATION ABOUT LIMITS FOR PAYMENT TRANSACTIONS COMMISSIONED IN THE MOBILE APP

Maximum daily limits of payment transactions in the mobile app were set, which amount to:

- 1) PLN 50,000: with respect to transfers to account;
- 2) PLN 3,000: with respect to transfers to telephone;
- 3) PLN 20,000: with respect to operations initiated with the use of a BLIK code or cheque;
- 4) PLN 20,000: for contact-less BLIK payments.

Maximum daily limits of payment transactions in the mobile app were set for persons aged 13-18, which amount to:

- 1) PLN 5,000: with respect to transfers to account;
- 2) PLN 3,000: with respect to transfers to telephone;
- 3) PLN 5,000: with respect to operations initiated with the use of a BLIK code or cheque;
- 4) PLN 5,000: for contact-less BLIK payments.

For express transfers commissioned via on-line banking, the maximum limits are specified in a separate notification.
